#### I. Call to Order / Roll Call / Determination of Quorum / Pledge of Allegiance

The River to Sea Transportation Planning Organization (TPO) Bicycle/Pedestrian Advisory Committee (BPAC) meeting was called to order at 2:02 p.m. by Chairperson Ted Wendler. The roll was called, and it was determined that a quorum was physically present. The meeting was held in a hybrid format with eleven voting and three non-voting members physically present; and three voting and two non-voting members virtually present.

### MOTION: A motion was made by Mr. Mostert to allow members attending virtually to participate and vote. The motion was seconded by Mr. Storke and carried unanimously.

The Pledge of Allegiance was given.

#### II. <u>Public Comment/Participation</u>

Chairperson Wendler welcomed the new BPAC members, Lee Rogowski and Robert Tomei.

#### III. <u>Action Items</u>

#### A. <u>Review and Approval of the April 10, 2024 BPAC Meeting Minutes</u>

MOTION: A motion was made by Mr. Lodge to approve the April 10, 2024 BPAC meeting minutes. The motion was seconded by Mr. Mostert and carried unanimously.

#### IV. <u>Presentation and Discussion Items</u>

#### A. <u>Presentation and Discussion of the Draft FY 2024/25 to FY 2028/29 Transportation Improvement Program</u> (TIP)

Mr. Harris provided detailed information about the proposed draft five-year TIP, covering expenditure amounts and funding for all projects. He explained the funding sources and noted that the draft TIP will be back next month for a recommendation of approval and will take effect on July 1, 2024; he discussed some of the specific projects and their funding types.

Mr. Harris addressed BPAC members' questions regarding expenditures and various projects; differences between regional and SUN Trail projects; the status of the LPGA interchange reconstruction; and the design progress of the Complete Streets project on Beach Street.

Ms. Nicoulin mentioned that although larger projects were not included in this presentation, they are listed in the actual TIP document. The projects that were highlighted in the presentation included member government applications received by the TPO.

#### B. <u>Presentation and Discussion of the Draft List of Prioritized Bicycle and Pedestrian Projects</u>

#### [Handout provided]

Mr. Harris clarified that the initial agenda emailed to the members had an incorrect project list, but it was revised and resent with the correct list. He provided detailed information on the draft List of Prioritized Bicycle and Pedestrian Projects, highlighting this year's applications and their rankings.

Mr. Harris addressed BPAC members' questions regarding several aspects of project management; the number of projects on the Priority List expected to be funded next year; whether projects lose their ranking if they fail to get funding; the implications of not having a local match; the possibility of reprioritizing projects based on new information that is submitted; projects that are withdrawn and the reasons given for withdrawal; and the source of the funding for the Howland Boulevard project.

#### C. Presentation and Discussion of the Draft List of Shared-Use Non-Motorized (SUN) Trail Projects

Mr. Harris provided detailed information about the Draft List of Shared-Use Non-Motorized (SUN) Trail Projects. He noted that several projects moved up to Tier A.

Mr. Harris addressed BPAC members' questions regarding various projects and the funding for those projects.

#### V. Staff Comments

#### → NHTSA Finalizes Key Safety Rule to Reduce Crashes and Save Lives

Mr. Harris discussed NHTSA finalizing a new key safety rule to reduce crashes and save lives by equipping vehicles with AEB (Automatic Emergency Braking) which will be able to detect pedestrians. He showed an NBC news video that demonstrated how AEB works.

Mr. Harris stated that the Florida Greenways and Trails Council met and reranked the regional trails with the Coast-to-Coast Trail being ranked as number one and the St. Johns River to Sea Loop Trail as number two.

Mr. Harris noted Bike/Walk Central Florida's Operation Best Foot Forward crosswalk enforcement schedule for April and May.

#### VII. BPAC Member Comments

Dr. Aufdenberg stated that he rode his bike to the Tomoka Town Center Mall, and there is great bike parking there. There are also complete sidewalks to ride on going from the Volusia Mall to Tomoka Center.

Mr. Coletti stated that last month he discussed rumble strips on SR A1A. He noted that they are installing them on the white line, and he thanked FDOT. He asked Ms. Stroger if they were planning to resurface the area between Old Kings Road and Colbert Lane near the Lehigh Trail.

Ms. Stroger stated that she would look into that and get back to him.

Mr. Coletti stated that he rides the Ormond Scenic Loop frequently and it would be nice if there was a bike lane added where room permits.

Ms. Belin noted that she rides in that area a lot and it is not a safe area for bicyclists.

Mr. Rogowski stated that he rides his bike from City Center in Port Orange to the Riverside Esplanade and there are a few places that need to be more bike-friendly. He also noted that many roads are much more bike-friendly.

Mr. Lowry stated that he witnessed a woman get hit this morning at Clubhouse Drive/Palm Coast Parkway area. He thinks there is a lack of sidewalks there. He stated that a few weeks ago near Florida Park Drive and the Publix Plaza, a 12-year-old kid was knocked down by a vehicle.

Mr. Wendler suggested that Mr. Lowry attend and participate in some of the Palm Coast City Council meetings.

Mr. Mostert stated that he wanted to show appreciation to Ms. Ardito; he went into JC's Bike Shop, mentioned Ms. Ardito's name and the employees stated they thought highly of her. He asked if the AEBs were well established and if they had been used in Europe for a while.

Mr. Harris stated that he believes AEBs were implemented in Europe.

Mr. Mostert asked about the Navy Canal being a runway protection zone.

Mr. Harris stated that on the west side of the sidewalk on Clyde Morris Boulevard, signs state there is no standing/no stopping in that zone, so you must keep moving. The city is not able to encroach upon that area.

Ms. Sharp stated that she rides in that area and signs are on both sides of Clyde Morris Boulevard. The canal and trail that people are using are not within that boundary. A year or so ago, the BPAC discussed having someone from the Federal Aviation Administration (FAA) attend one of the BPAC meetings to explain that, but they have not done so.

Mr. Lodge asked if anyone is participating in the Make Every Ride Count Initiative this month and he suggested signing up on the Love to Ride app.

Mr. Lunceford stated that at yesterday's Volusia County Council meeting, the Council authorized Votran to start exploring fare increases. He noted that they will be holding public meetings over the next month and the TPO will be sharing information throughout the process.

Ms. Ardito discussed the Active Transportation Infrastructure Investment Program (ATIIP) stating that there is \$45 million in funding available. The deadline to submit is June 17, 2024. She also noted that the Active Transportation for All Workshop is scheduled for January 31, 2025, and if anyone is interested in helping prepare for that they should contact her.

The Florida Department of Transportation (FDOT) requests approval of an amendment to the FY 2024/25 to FY 2028/29 Transportation Improvement Program (TIP) to include projects with funds rolling forward from FY 2023/24 to FY 2024/25. Each year, FDOT develops the tentative 5-Year Work Program which becomes effective on July 1st. The TPO incorporates the tentative Work Program into the new Transportation Improvement Program (TIP), which was adopted by the TPO Board on June 26, 2024, and also becomes effective on July 1st. Year 1 of the TIP and the Work Program should always match. However, when the new TIP and Work Program become effective, there are often projects that were supposed to get authorized prior to June 30th (i.e.: when the previous TIP and Work Program were in effect) but did not. These projects will automatically roll forward in the Work Program, but not in the TIP. Hence, there is a need to reconcile the two documents and bring the new TIP up-to-date. This is accomplished by a routine procedure that is processed every year known as a "roll forward" TIP amendment.

This roll forward amendment request, as summarized in the FDOT request letter dated July 16, 2024, is being made to ensure that the projects shown in the TIP are consistent with the projects shown in FDOT's Five Year Work Program.

In addition to the "roll forward" projects, this amendment also includes the following five projects as summarized in the FDOT request letter:

- Project 437025-3 Flagler-Flagler County Terminal Building
- Project 454714-1 Loop Road Connector Phase 4
- Project 454715-1 Matanzas Woods Parkway Extension Loop Road Phase 2A
- Project 454716-1 Palm Coast Parkway Extension Loop Road Phase 3
- Project 454881-1 US 92 New Intersection

The proposed amendment is authorized in Resolution 2024-## and incorporates the projects with funding that rolled forward from FY 2023/24 to FY 2024/25 into the FY 2024/25 to FY 2028/29 TIP and the amendments to the additional five projects. #### RE: Request to Amend Fiscal Year (FY) 2025-2029 Transportation Improvement Program (TIP) – Annual Roll Forward

Dear Ms. Nicoulin:

The purpose of this letter is to request River to Sea TPO amend the FY 2025-2029 TIP with the Annual Roll-Forward Report. The Roll Forward report reconciles differences between the TIP and Florida Department of Transportation's (FDOT) Adopted Five-Year Work Program. This annual process is routine and assists the TPO with identifying projects using federal funds that were not authorized during the previous state fiscal year (FY 2024). These projects have automatically "rolled forward" in the FDOT Adopted Five-Year Work Program as of July 1, 2024. This amendment ensures that year one of the TIP matches year one of FDOT's Adopted Five-year Work Program.

The reason for this amendment is to ensure projects with federal funding can be authorized prior to the new Federal Fiscal Year (FFY) beginning on October 1 each year. Until then, Federal Highway Administration (FHWA) and Federal Transit Administration (FTA) continue to recognize the FY 2024 – 2028 TIP as the effective document. Adopting the Roll Forward Report and amending it into the FY 2025-2029 TIP ensures projects will continue to be authorized without interruption.

The affected projects are listed in the attached Roll-Forward Report dated July 1, 2024. The TPO is requested to add this report to the FY 2025-2029 TIP in its entirety. A separate report for commuter rail projects is also attached.

Project #437025-3 is in the FY 2025-2029 TIP, however this project received additional funding from a legislative appropriation. This project should be updated in the TIP to reflect current funding for the project.

Additionally, several other projects received legislative appropriations. These projects are not presently in the TIP, however the TPO may choose to add the projects to the TIP for transparency purposes.





# All Aboard! SunRail Service at new DeLand Station to begin Monday, August 12, 2024

DELAND, Fla. – SunRail is pleased to announce the opening of its new DeLand Station and start of passenger service on Monday, August 12. The DeLand station, the northernmost stop on the 61-mile commuter rail system, is located at 2491 Old New York Avenue, DeLand.

SunRail operates Monday through Friday, connecting communities throughout Orange, Osceola, Seminole, and Volusia counties in Central Florida. SunRail offers an affordable, stress-free travel option for commuting to work and school and exploring Central Florida to discover the rich cultural, recreational, and culinary experiences surrounding each of the 17 stops.

Fares start as low as \$2, with discounts available for seniors, youth, and individuals with disabilities. All trains and stations are fully accessible. Passengers can purchase tickets via the SunRail Mobile app, available in the App Store and Google Play, or at ticket vending machines located on station platforms.

# **Frequently Asked Questions**

# WHAT IS TRAIL-GO AND HOW IS IT ADMINISTERED?

TRAIL-GO the Local Trail Management Grant is a competitive program which provides grants to local governmental entities for the operation and maintenance of <u>trails located within the</u> <u>Florida Greenways and Trails System (FGTS)</u>. A map of the FGTS is located <u>here</u>. The Florida Department of Environmental Protection (DEP), Office of Greenways and Trails (OGT) administers TRAIL-GO.

# WHO MAY APPLY FOR TRAIL-GO FUNDS?

Local governments in the State of Florida

# WHO IS PRIORITY GIVEN TO?

DEP will evaluate the applications and will give **priority** to each of the following:

- A local government that provides cost share for the costs associated with the operation and maintenance of the trails (except for trails within fiscally constrained counties or rural areas of opportunity);
- o Trails within fiscally constrained counties or rural areas of opportunity, and
- Trails within the Florida Wildlife Corridor.

# HOW DO I APPLY?

Applicants must submit a completed TRAIL-GO Grant Application during the announced submission period, **AUGUST 1 – 31, 2024**. The Department will announce the application submission period in the Florida Administrative Register prior to each cycle. Application period will be open for thirty (30) days or by the deadline in the announcement.

**TRAIL-GO Grant Applications must be submitted through DEP's Grantee Portal (Portal) at** <u>https://fdep.force.com/grants/s/</u>. The Portal will not accept any applications submitted after 5:00 p.m. EDT on August 31, 2024. Incomplete applications will not be considered. Applicant <u>must</u> upload proof from the local government that the person submitting the application has the authority to apply for funds on behalf of the county and a letter indicating that the local government approves of the project. For assistance using DEP's Grantee Portal, contact OGT staff via email or phone 850-245-2052.

Trail project <u>MUST</u> be located within the FGTS to be eligible. Failure by an applicant to submit an application by August 31, 2024, will result in the application being declared ineligible for funding consideration during the current funding cycle. <u>Applications will be</u> <u>awarded on a first</u> <u>come, first served basis, with priority being given to the above referenced categories.</u>

# WHAT IS THE FLORIDA GREENWAYS AND TRAILS SYSTEM? Section 260.014, F.S.

Florida Greenways and Trails System (FGTS) is the vision of a statewide system of connected greenways and trails. A map is located <u>here</u>.

# WHAT IS THE FLORIDA WILDLIFE CORRIDOR? <u>Section 259.1055, F.S.</u>

The Florida Wildlife Corridor means the conserved lands and opportunity areas defined as priority one, two, and three categories of the Florida Ecological Greenways Network. A map is located <u>here</u>.

# WHAT IS THE RURAL AREA OF OPPORTUNITY? Section 288.0656, F.S.

Rural Area of Opportunity (RAO), also known as Rural Economic Development Initiative (REDI), means a rural community, or a region composed of rural communities, designated by the Governor, which has been adversely affected by an extraordinary economic event, severe or chronic distress, or a natural disaster or that presents a unique economic development opportunity of regional impact. A map is located <u>here</u>.

# WHAT IS THE MAXIMUM GRANT AMOUNT?

The TRAIL-GO program receives \$4 million annually contingent upon legislative appropriation. Individual applications are limited to one project request in the request amount of \$200,000. Applicants may submit more than one project application during the submission period.

# WHAT CAN I USE TO MATCH A TRAIL-GO GRANT?

Cash and In-kind Services.

# HOW ARE TRAIL-GO GRANTS AWARDED?

OGT evaluates each eligible application and determines if they meet the requirements for priority level. Those given **priority** will be sorted by date and time of receipt and recommended for funding in that order. Those not meeting the **priority** requirements will be sorted by date and time of receipt and recommended for funding in that order, after the priority projects have been funded. Based on this evaluation, OGT will prepare and submit a recommendation to the Director of the Division of Recreation and Parks for funding consideration. An estimated timeframe for funding projects is located <u>here</u>.

DEP's performance and obligation to award program grants is contingent upon an annual appropriation by the Florida Legislature. Should the project receive funding, the <u>grantee will have</u> <u>until July 1, the start of the state's fiscal year, to complete the project.</u>

# WHAT TYPES OF PROJECTS ARE ELIGIBLE FOR THE TRAIL-GO PROGRAM?

A local government may only use grant funds for the operation and maintenance of trails, including, but not limited to, the purchase of equipment and capital assets; the funding of necessary repairs to ensure the safety of trail users; and other necessary maintenance, such as pressure washing, bush pruning, and clearing debris. <u>A local government may not use grant funds</u> for the planning, design, or construction of trails. A list of examples of eligible TRAIL-GO projects can be found <u>here</u>. This list is not exhaustive and is offered only to provide examples.

As part of its summer public outreach, the River to Sea TPO reaches out to children to teach them about bicycle safety. 
